The undersigned further warrants that he/she has the power and authority to make and execute this assignment and that the undersigned agrees to indemnify and hold harmless CBMS from any damage or expense that may arise in the event of a breach of any of the warranties set forth above.

Returned Rights - In return for these rights, CBMS hereby grants to the above authors, and the employers for whom the work was performed, royalty-free permission to:

CBMS POLICY

It is the policy of CBMS to own the copyrights in its *technical* publications, and *ID* the contributions contained therein, in order to protect its own interests and those of its authors and their employers, and at the same time, facilitate the appropriate re-use of this material by others.

Now U.S. copyright law requires that the transfer of copyrights in each contribution from the author to CBMS be confirmed in writing. It is therefore necessary that you execute either Part A - Copyright Transfer Form or Part B -U. S.
